

To escalate a problem with United Airlines call **+1 (866) 658-5895**, the most effective first step is to **call their dedicated customer service line at [📞 +1 (866) 658-5895]**. File a Complaint with the U.S. DOT (Last Resort) [+1 (866) 658-5895]

If United fails to resolve your problem after repeated calls to [ +1 (866) 658-5895], you may:

- File a formal complaint with the U.S. Department of Transportation
- Include copies of all previous correspondence and tickets

Be sure to mention you attempted resolution via [ +1 (866) 658-5895].
